Only Afghan Hounds, Azawakhs, Basenjis, Borzois, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharoah Hounds, Portugese Podengos, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Thai Ridgebacks and Whippets who are at last one year of age on the day of the test may be entered. The hound must be individually registered with the AKC, or an AKC recognized foreign registry, or have an ILP or PAL number from the AKC. Or Azawaks, Portugese Podengos, Sloughis and Thai Ridgebacks recorded with the AKC FSS. Spayed and neutered hounds are eligible. Monorchid and cryptorchid dogs are NOT eligible. Late, incomplete, conditional, unsigned or unpaid entries will NOT be accepted. Entries will NOT be acknowledged by mail. Substitutes for lame or in-season hounds will be allowed if substitute has the same owner and the trial secretary is notified before the close of gate entries. A battery powered continuous loop lure machine will be used; backup equipment will be available. Lure course will consist of highly visible plastic. There will be a \$5.00 fine for any loose hounds on the field which are not in the course in process. Course plan will be 600 yards of the trial course plan for that day.

**Junior Courser:** Open to all eligible hounds. A hound running alone shall receive a certification from a judge on one date and a second certification from a different judge on a later date stating that the hound completed at least a 600 yard course with a minimum of 4 turns. The hound must complete the course with enthusiasm and without interruption.
